INVOLVIM KICK-OFF: SHAPING POLICY FOR IMMIGRANT SUPPORT

The INVOLVIM project focuses on influencing local policies to improve the lives of work-based immigrants by enhancing support services. It launched with a Kick-off meeting in June 2024 in Finland, where partners set the stage for collaboration and shared strategies for creating more inclusive communities.

INTERREG INVOLVIM PROJECT KICK-OFF IN SEINÄJOKI, FINLAND

Finland Meeting and Best Practices: "In Finland, partners shared successful practices aimed at supporting work-based immigrants, highlighting collaboration in shaping innovative policies."

The INVOLVIM project kicked off in Seinäjoki, Finland, bringing together partners from five European regions to collaborate on improving local policies for supporting work-based immigrants. The event highlighted best practices and strategies to enhance informal and voluntary services for immigrant integration. Discussions focused on how regions can tailor their policies to better support inclusion, with the goal of creating more welcoming communities. The Finland meeting set the foundation for future activities within the project.

These best practices highlighted the importance of informal and voluntary services in immigrant integration. The discussions served as a foundation for influencing local policies, aiming to create more inclusive communities across all partner regions. The organizations represented at the INVOLVIM kick-off meeting in Seinäjoki included local partners like SIMHE (University of Vaasa), Moni-info and Wiise Association, who shared their expertise on supporting work-based immigrants. These organizations play a key role in providing voluntary services and integration support, serving as examples for other European regions in the project. Their best practices, particularly in the areas of informal support and community engagement, were central to the learning and collaboration during the event.
